19. Question: Attachment A, Contract, Section 4.1, Page 38: What is Exhibit C and where can it be found?

Response: Please see Contract Section 2., page 37: Contractor's Financial Proposal, to be submitted with Technical Proposal, will become Exhibit C.

20. Question: Will DBM consider working with the awardee to plan the order of the projects to be assessed to assist with resource planning?

21. Question: Is it possible for project to be evaluated more than once during the course of this contract?

Response: We do not expect this to occur.

22. Question: Number 14 on the list of Major IT Development Projects is Enterprise Resource Planning Systems Review. Is this the same as the Business Processes Systems Planning project (sub program code P003)?

Response: Yes.

23. Question: Is it acceptable for one resume to be submitted to fill multiple positions?

Response: Yes.

24. Question: In Amendment #1, changes 7 and 8 seem to be duplicates. Is this correct or should Change 8 refer to Section 3.4.3.3, Section D, Page 32?

Response: Change 8 should refer to Section D.

25. Question: Section 3.4.4 Para A and Section 3.4.4 Para E are very similar. Can you clarify the difference in the information you are looking for? Can we use the same projects in both areas?

Response: 1) Yes these sections are very similar. Section A emphasizes providing an overview of the Offeror's experience while Section E emphasizes providing References. 2) The same projects can be used in both areas.

26. Question: Section 3.4.4 Para D asks for resumes for **key personnel**. Section 3.4.5 asks for resumes for **all personnel proposed**. Do you want to see all the resumes grouped together in one section or divided between the 2 sections of the proposal?

Response: Divided between the 2 sections of the proposal.
